Promotion Official Rules

Prizes will be awarded randomly, and the odds of being selected as a winner depend upon the number of entries made during the Promotion Period.
- 2. ELIGIBILITY: Only open and offered to legal U.S. residents who reside in Indiana and who are 18 years of age or older at the time of entry and who are members with a valid email or phone number on file] ("Entrant"). HOW TO PLAY: Customers who scan a My Good Rewards Card when purchasing a \$1 \$3,000 Jumbo Cash Scratch-off ticket receive a chance to enter the Promotion and win a prize pack containing a \$100 Good to Go gift card and two hundred (200) \$1 \$3,000 Jumbo Cash Scratch-offs. The number of entries will correspond to the number of Scratch-offs purchased. Self-Service vending purchases are excluded.
- 4. HOW TO PLAY WITHOUT PURCHASE: To enter by mail without a purchase, print your complete name, My Good Rewards ID number, complete mailing address (no P.O. boxes), city, state, zip code, date of birth (mm/dd/yyyy), valid daytime and evening phone numbers, and email address on a 3" x 5" card and mail your entry with first-class postage to: Good to Go Hoosier Lottery Promotion, 102 N. US 35, Winamac, IN 46996. Limit one entry per household. Each entry must be mailed in a separate envelope, and all entries must be received by Sponsor by 11:59 PM on November 1, 2022. Failure to comply with this or any other Official Rules will result in disqualification. No mechanically reproduced entries are permitted. Illegible or incomplete entries are void. Not responsible for lost, late, damaged, postage due, misdirected entries or entries not received by the entry deadline. The same odds apply to both mailed-in entries and instore entries.

- 6. DRAWING: A random drawing from all eligible entries will take place on or about November 2, 2022. Winners will be notified by email and/or phone. Winners must provide valid identification when claiming any prize. Winners may not substitute, assign or transfer prize or redeem prize for cash, but Sponsor and the Hoosier Lottery reserve

the right to substitute prize with prize of equal or greater value if advertised prize becomes unavailable.

7. Potential winners are subject to verification of eligibility and compliance with the sweepstakes rules before any prize will be awarded. Taxes on any prize are the sole responsibility of the winner.

Entries not legitimately obtained and/or used in accordance with these Official Rules are void. Use of an automated system to participate is prohibited and will result in disqualification. All potential winning entries are subject to verification by Sponsor, whose decisions are final and binding. All federal, state, and local laws and regulations apply. The Released Parties assume no responsibility for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, wireless, telephone equipment, electronic, computer, hardware, or software malfunctions of any kind, or

inaccurate transmissions of or failure to receive entry information by Sponsor on account of technical problems or traffic congestion on the Internet or via mobile device transmission or any combination thereof.

The Released Parties assume no responsibility for injury or damage to an Entrant's or any other person's computer/mobile device related to or resulting from downloading any materials in the Promotion, for any unavailability of telephone lines, connections, or cellular telephone service, or for any other technical malfunctions that may interfere with an Entrant's attempt to enter the Promotion.

Any attempt to deliberately damage any service or website or to undermine the legitimate operations of the Promotion may be a violation of civil or criminal laws, and Sponsor reserves the right to disqualify and seek damages from any such person to the fullest extent of the law.
